**AMENDMENT THIRTEEN
To HHSC CONTRACT NO. 529-16-0007-00001**

THIS AMENDMENT THIRTEEN (the "**Amendment**") to HHSC Contract No. 529-16-0007-00001 (the "**Agreement**") is entered into between the HEALTH AND HUMAN SERVICES COMMISSION ("**HHSC**" or the "**State**"), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC ("**CONTRACTOR**"), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 1501 S. MoPac Expressway, Austin, TX 78746. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a "Party" and collectively as the "Parties."

WHEREAS, in accordance with Article 9 of the Agreement, the Parties wish to amend the Agreement in order to provide additional dedicated CONTRACTOR technical resources to the State to work on system modifications for the Long Term Care (LTC) Portal and the Claims Management System (CMS) rules engine base enhancement projects.

WHEREAS, the Parties wish to incorporate the terms and conditions of Amendment Thirteen into the Agreement.

NOW, THEREFORE, the Parties hereby amend and modify the Agreement as follows:

- 1. ADDITIONAL PERSONNEL FOR BASE ENHANCEMENT TEAM** HHSC has requested an increase in capacity to accomplish system modifications through the base enhancement team. This Amendment will increase the annual capacity of the LTC Base Enhancement Team by three (3) full time equivalents (FTEs). The FTEs are expected to be one (1) Business Analyst and (2) Developers. This results in an increase from twelve (12) FTEs annually to fifteen (15) FTEs annually for the base enhancement team.
- 2. MODIFICATION TO LTC – 0209 (EXHIBIT B, ATTACHMENT 22)**. Requirement LTC – 0209 of the Agreement is modified to read as follows:
LTC – 0209
Resources
Schedule and prioritize work for **fifteen (15)** dedicated technical FTEs according to system enhancement priorities determined by HHSC for LTC projects.
- 3. Modification to Exhibit C, Item 2.a of the Agreement**. Effective FY19, the hours to be performed by CONTRACTOR as directed by HHSC staff for modifications to the TMMIS that are related specifically to LTC requirements in Exhibit B, Attachment 22, to this Agreement is modified to 28,800 hours from 23,040.

- 4. **PRICING.** CONTRACTOR will perform the Services set forth in Amendment Thirteen on a "fixed fee" basis in the amount and under the terms set forth in Amendment Thirteen. Total Fees under this Amendment will not exceed ONE MILLION, THREE HUNDRED TWENTY FOUR THOUSAND, FOUR HUNDRED FIFTY FIVE DOLLARS (\$1,324,455).
 - a. CONTRACTOR pricing is based on the use of the following resources. The resource positions are listed in the table below with the appropriate rates.

- 5. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.
- 6. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently amended or modified by the Parties.
- 7. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
- 8. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the CONTRACTOR under the Agreement in consideration of certain payments to be made by HHSC. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
- 9. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully herein.
