AMENDMENT SIXTEEN
TO HHSC CONTRACT NO. 529-16-0007-00001

THIS AMENDMENT SIXTEEN (the “**Amendment**”) to HHSC Contract No. 529-16-0007-00001 (the “**Agreement**”) is entered into between the HEALTH AND HUMAN SERVICES COMMISSION (“**HHSC**” or the “**State**”), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC (“**CONTRACTOR**”), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 1501 S. MoPac Expressway, Austin, TX 78746. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a “**Party**” and collectively as the “**Parties**.”

WHEREAS, in accordance with Article 9 of the Agreement, CONTRACTOR submitted to HHSC, and HHSC accepted, Change Order Request response 19 - 008, Version 3.0, which is attached to this Agreement as **Attachment A (“COR 19 - 008”)**. COR 19 - 008 modifies the Scope of Work of the Agreement. The HHSC Office of Inspector General (OIG) received funding in the 85th Legislative Session to expand the OIG’s data analytic functionality. This COR implements enhancements to existing Texas Medicaid and Healthcare Partnership (TMHP) solution as one component of the OIG’s overall Project to expand its data analytics functionality. It will expand the OIG’s data analysis abilities through the implementation of software tools, modifications to existing data structures, and development of Business Objects report templates that staff can utilize to support OIG business needs.

WHEREAS, the Parties wish to incorporate the terms and conditions of COR 19 - 008 into the Agreement.

NOW, THEREFORE, the Parties hereby amend and modify the Agreement as follows:

1. **INCORPORATION OF COR 19 - 008.** The requirements, terms and conditions of COR 19 - 008 are incorporated into the Agreement. If the requirements, terms and conditions of COR 19 - 008 in any way conflict with a term or condition in the remainder of this Amendment, the term or condition in the remainder of this Amendment will control with respect to this Amendment only.
2. **PRICING.** CONTRACTOR will perform the Services set forth in COR 19 - 008 on a “fixed fee” basis in the amount and under the terms set forth in COR 19 - 008. Total Fees under this Amendment will not exceed ONE MILLION TWENTY THOUSAND TWO HUNDRED SIXTY FOUR DOLLARS (\$1,020,264).
3. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.


4. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below, and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently amended or modified by the Parties.
5. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
6. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the CONTRACTOR under the Agreement in consideration of certain payments to be made by HHSC. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
7. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully herein.
