To HHSC CONTRACT NO. 529-16-0007-00001**

THIS AMENDMENT TWENTY-FOUR (the “**Amendment**”) to HHSC Contract No. 529-16-0007-00001 (the “**Agreement**”) is entered into between the HEALTH AND HUMAN SERVICES COMMISSION (“**HHSC**” or the “**State**”), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC (“**CONTRACTOR**”), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 323 Congress Avenue, Suite 150, Austin, TX 78701. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a “Party” and collectively as the “Parties.”

In accordance with Article 9 of the Agreement, CONTRACTOR submitted to HHSC, and HHSC accepted, Change Order Request response 19 - 012, Version 3.0, which is attached to this Amendment as **Attachment A (“COR 19 - 012”)**. COR 19 - 012 modifies the Scope of Work of the Agreement. The purpose of this Amendment is to establish Texas Medicaid Management Information System (TMMIS) functionality that will allow HHSC to levy an administrative fee on claims and payments for School Health and Related Services (SHARS). The funds collected as a result of the SHARS administrative fee are used for Health and Human Services administrative activities, including compliance monitoring, technical assistance, and to establish and maintain an audit reserve fund. The Parties now wish to incorporate the terms and conditions of COR 19 - 012 into the Agreement.

The Parties hereby amend and modify the Agreement as follows:

1. **INCORPORATION OF COR 19 - 012.** The requirements, terms and conditions of COR 19 - 012 are incorporated into the Agreement. If the requirements, terms and conditions of COR 19 - 012 in any way conflict with a term or condition in the remainder of this Amendment, the term or condition in the remainder of this Amendment will control with respect to this Amendment only.
2. **PRICING.** CONTRACTOR will perform the Services set forth in COR 19 - 012 on a “fixed fee” basis in the amount and under the terms set forth in COR 19 - 012. Total Fees under this Amendment will not exceed NINE HUNDRED SEVENTY-FOUR THOUSAND FORTY-TWO DOLLARS (\$974,042).
3. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.
4. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently terminated, amended or modified by the Parties.

5. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
6. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the CONTRACTOR under the Agreement in consideration of certain payments to be made by HHSC. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
7. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent expressly modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully therein.
