**AMENDMENT THIRTY-TWO
To HHSC CONTRACT NO. 529-16-0007-00001**

THIS AMENDMENT Thirty-Two (the “**Amendment**”) to HHSC Contract No. 529-16-0007-00001 (the “**Agreement**”) is entered into between the HEALTH AND HUMAN SERVICES COMMISSION (“**HHSC**” or the “**State**”), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC (“**CONTRACTOR**”), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 323 Congress Avenue, Suite 150, Austin, TX 78701. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a “Party” and collectively as the “Parties.”

WHEREAS, in accordance with Article 9 of the Agreement, the Parties wish to amend the Agreement in order to replace Amendment Fifteen COR 19-007, version 2.0 in its entirety with COR 19-007 Version 5.0, which is attached to this Amendment as **Attachment A (“COR 19-007”)**. COR 19-007 modified the Scope of Work of the Agreement in response to Senate Bill (SB) 200, 84th Texas Legislature, Regular Session, 2015, requiring the State to consolidate and streamline its provider enrollment and data management processes. Amendment Fifteen was intended to implement, modify and remove redundant processes/procedures, resulting from the vendor’s PMES solution’s integration into the Texas Medicaid Management Information System (TMMIS).

WHEREAS, the Parties wish to replace the terms and conditions of COR 19-007, Version 2.0 in the Agreement with this Amendment.

NOW, THEREFORE, the Parties hereby amend and modify the Agreement as follows:

1. **CHANGE IN PRICING METHODOLOGY.** This Amendment will revise the pricing methodology from “fixed fee” to “time and materials”. This will allow for CONTRACTOR to bill for actual hours worked using the CONTRACTOR Rates and to monitor the progress of this Project in order to maximize the use of resources. Therefore, the Statement of Work and associated costs are being updated to reflect the revised methodology. The overall project costs will be increased by ONE HUNDRED FORTY-SIX THOUSAND FOUR HUNDRED EIGHTY-TWO DOLLARS (\$146,482).
2. **SCOPE AND PRICING.** CONTRACTOR will amend the scope to align with HHSC’s revised plan for a modernized provider management system. CONTRACTOR will, in consideration of the payments to be made by HHSC under this Amendment, perform the Services set forth in COR 19-007, Version 4.0, on a “time and material” basis in the amount and under the terms set forth. Total Fees under this Amendment will not exceed SIX MILLION FOUR HUNDRED THIRTY-FOUR THOUSAND NINE HUNDRED EIGHTY-EIGHT DOLLARS (\$6,434,988).


3. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.
4. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently terminated, amended or modified by the Parties.
5. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
6. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the CONTRACTOR under the Amendment in consideration of certain payments to be made by HHSC. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
7. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent expressly modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully therein.


