**AMENDMENT FORTY-ONE  
To HHSC CONTRACT No. 529-16-0007-00001**

THIS AMENDMENT FORTY-ONE (the “**Amendment**”) to HHSC Contract No. 529-16-0007-00001 (the “**Agreement**”) is entered into between the HEALTH AND HUMAN SERVICES COMMISSION (“**HHSC**” or the “**State**”), an administrative agency within the executive department of the State of Texas and having its principal office at 4601 W. Guadalupe, Austin Texas 78751, and Accenture State Healthcare Services LLC (“**CONTRACTOR**”), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 323 Congress Avenue, Suite 150, Austin, TX 78701. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a “Party” and collectively as the “Parties.”

**WHEREAS**, in accordance with Article 9 of the Agreement, the Parties wish to amend the Agreement in order to replace Amendment Thirty COR 19-009, version 6.0 in its entirety with COR 19-009 Version 10.0, which is attached to this Amendment as **Attachment A (“COR 19-009, version 10.0”)**. COR 19-009, version 6.0, modified the Scope of Work of the Agreement to add, remove, and modify Electronic Visit Verification (EVV) requirements to establish sufficient structure around CONTRACTOR’S responsibilities for vendor management, training, provider relations, and other operations functions. The Project also addressed payments made to CONTRACTOR for these services.

**WHEREAS**, the Parties wish to replace the terms and conditions of COR 19-009, Version 6.0 in the Agreement through this Amendment.

**NOW, THEREFORE**, the Parties hereby amend and modify the Agreement as follows:


1. **DELETION AND REPLACEMENT OF COR 19-009, VERSION 6.0.** The Parties hereby amend the contract by deleting COR 19-009, version 6.0, and replacing it with COR 19-009, version 10.0.
2. **PROJECT IMPLEMENTATION DATE.** The implementation date of August 2021 will be extended until no later than February 28, 2022.
3. **SCOPE AND PRICING.** CONTRACTOR will, in consideration of the payments to be made by HHSC under this Amendment, perform the Services set forth in COR 19-009, Version 10.0, on a “fixed fee” basis in the amount and under the terms set forth; provided however, the fees will change according to the adjusted Billing Schedule. Total Fees under this Amendment will not exceed THIRTEEN MILLION NINE HUNDRED SEVENTY THOUSAND SIX HUNDRED FORTY-TWO DOLLARS (\$13,970,642).
4. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.


5. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently terminated, amended or modified by the Parties.
6. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
7. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the CONTRACTOR under the Amendment in consideration of certain payments to be made by HHSC. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
8. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent expressly modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully therein.
