**AMENDMENT FIVE  
TO HHSC CONTRACT NO. 529-16-0007-00001**

THIS AMENDMENT FIVE (the "**Amendment**") to HHSC Contract No. 529-16-0007-00001 (the "**Agreement**") is entered into between the HEALTH AND HUMAN SERVICES COMMISSION ("**HHSC**" or the "**State**"), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC ("**CONTRACTOR**"), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 1501 S. MoPac Expressway, Austin, TX 78746. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a "Party" and collectively as the "Parties."

**WHEREAS**, in accordance with Article 9 of the Agreement, the Parties wish to amend the Agreement in order to replace Amendment Three COR 17 – 030 which modified the Scope of Work of the Agreement in order to streamline Appeals, Complaints, and Resolutions (ACR) submissions into one application that is utilized by both CONTRACTOR and State staff.

**WHEREAS**, the Parties wish to replace the terms and conditions of Amendment Three COR 17-030 , Version 1.4 in the Agreement with this Amendment.

**NOW, THEREFORE**, the Parties hereby modify the Agreement as follows:

1. **ADJUSTMENT TO BILLING SCHEDULE FOR COR 17 - 030, VERSION 1.4.** Due to certain circumstances, the November 27, 2017 Execution Date of Amendment Three did not allow for work to commence as planned. Therefore, the parties are adjusting the Billing Schedule to commence in December 2017 and complete in November 2018.
2. **PROJECT STATUS MEETINGS.** The Deliverables related to Amendment Three COR 17 – 030 are modified to include Project Status meetings with HHSC to be conducted by CONTRACTOR including the creation and distribution of meeting minutes for HHSC approval.
3. **PRICING.** As agreed to in Amendment Three, CONTRACTOR will, in consideration of the payments to be made by HHSC under this Amendment, perform the Services set forth in COR 17-030, Version 2.0, on a "fixed fee" basis in the amount and under the terms set forth in COR 17-030, version 2.0; provided however, the fees will change according to the adjusted Billing Schedule. Total Fees under this Amendment will not exceed TWO MILLION TWO HUNDRED FIFTY THREE THOUSAND ONE HUNDRED NINETY DOLLARS (\$2,253,190).
4. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.

5. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below, and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently amended or modified by the Parties.
6. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
7. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in the Agreement apply to the Services and Deliverables to be provided by the CONTRACTOR under this Amendment, except to the extent those terms and conditions are hereby expressly amended. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
8. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully herein.


