

**HHSC CONTRACT 529-16-0007-00001F****AMENDMENT SIX  
TO HHSC CONTRACT NO. 529-16-0007-00001**

THIS AMENDMENT SIX (the "**Amendment**") to HHSC Contract No. 529-16-0007-00001 (the "**Agreement**") is entered into between the HEALTH AND HUMAN SERVICES COMMISSION ("**HHSC**" or the "**State**"), an administrative agency within the executive department of the State of Texas and having its principal office at 4900 North Lamar Boulevard, Austin Texas 78751, and Accenture State Healthcare Services LLC ("**CONTRACTOR**"), a limited liability corporation organized under the laws of the State of Delaware and having its principal place of business at 1501 S. MoPac Expressway, Austin, TX 78746. HHSC and the CONTRACTOR may be referred to in this Amendment individually as a "Party" and collectively as the "Parties."

**WHEREAS**, in accordance with Article 9 of the Agreement, CONTRACTOR submitted to HHSC, and HHSC accepted, Change Order Request response 18 - 004, Version 3.0, which is attached to this Agreement as **Attachment A ("COR 18-004")**. COR 18 - 004 modifies the Scope of Work of the Agreement in order to develop payment request processing functionality and contract compliance reporting functionality in the Texas Medicaid Management Information System (TMMIS). This would allow the Substance Use Disorder (SUD) users of the HHSC Source application to utilize TMMIS so that HHSC Source application can be retired.

**WHEREAS**, the Parties wish to incorporate the terms and conditions of COR 18-004 into the Agreement.

**NOW, THEREFORE**, the Parties hereby amend and modify the Agreement as follows:

1. **INCORPORATION OF COR 18 - 004**. The requirements, terms and conditions of COR 18 - 004 are incorporated into the Agreement. If the requirements, terms and conditions of COR 18 - 004 in any way conflict with a term or condition in the remainder of this Amendment, the term or condition in the remainder of this Amendment will control.
2. **HHSC PROGRAMS DEFINITION**. The definition of HHSC Programs set forth in Section 3.03(38) of the Agreement is deleted in its entirety and replaced with the following:

"38. "HHSC Programs" are defined as follows:

- Title XIX (includes all Services not otherwise covered by programs below)
- Children with Special Health Care Needs (CSHCN) Services Program
- Family Planning Title V and XX (FP)
- Long Term Care (LTC)
- Medical Transportation Program (MTP)
- Healthy Texas Women's program (formerly Texas Women's Health Program)
- Behavioral Health Services – Substance Use Disorder (SUD) Prevention, Intervention and Treatment".

3. **PRICING. CONTRACTOR** will perform the Services set forth in COR 18 - 004 on a "fixed fee" basis in the amount and under the terms set forth in COR 18 - 004. Total Fees under this Amendment will not exceed ONE MILLION DOLLARS (\$1,000,000).
4. **RETROSPECTIVE COST SETTLEMENT.** The costs incurred under this Amendment will be subject to the Retrospective Cost Settlement provisions included in Section 6.03 and Exhibit C of the Agreement.
5. **CLEAN AIR ACT AND FEDERAL WATER POLLUTION CONTROL ACT.** With respect to performing the Services under COR 18 - 004, **CONTRACTOR** agrees to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act (42 U.S.C. 7401-7671q) and the Federal Water Pollution Control Act as amended (33 U.S.C. 1251-1387).
6. **EFFECTIVE DATE.** This Amendment is effective upon the last signature date below, and will continue in full force and effect through the remainder of the Term of the Agreement unless subsequently amended or modified by the Parties.
7. **CAPITALIZED TERMS.** All capitalized terms in this Amendment shall have the meaning as set forth in Section 3.03 of the Agreement unless modified herein.
8. **INCORPORATION BY AMENDMENT.** The Parties agree that the terms and conditions set forth in this Amendment apply to the Services and Deliverables to be provided by the **CONTRACTOR** under the Agreement in consideration of certain payments to be made by **HHSC**. By signing this Amendment, the Parties expressly understand and agree that this Amendment is made a part of the Agreement as though it were set out word for word in the Agreement.
9. **ENTIRE AGREEMENT.** The Parties agree that the terms of the Agreement will remain in effect and continue to govern except to the extent modified in this Amendment. The Services and Deliverables under this Amendment are subject to all other terms and requirements of the Agreement as if set forth fully herein.


