AMENDMENT NO. 2**

THE HEALTH AND HUMAN SERVICES COMMISSION (“HHSC”) (“System Agency”) and the UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER SAN ANTONIO (“Performing Agency”/“Grantee”), collectively, the "Parties," to that certain Opioid Emergency Response Pilot (TRG) Contract effective February 1, 2018 and denominated HHSC Contract No. HHS00011460001 (“Contract”), now want to amend the Contract.

WHEREAS, the Parties want to revise the Contract to allow for successful completion of the Project.

The Parties therefore agree as follows:

1. This Amendment shall be effective August 29, 2020.
2. Article III, Contract Period and Renewal, of the Contract Signature Document, is hereby revised and restated in its entirety as follows:

The Contract is effective on February 1, 2018, and terminates on August 31, 2022, unless renewed or terminated pursuant to the terms and conditions of the Contract. The Parties may renew this Contract for two additional 12-month terms and subject to mutually agreeable terms and conditions.

3. Article V, Contract Amount and Payment for Services, is hereby revised and restated in its entirety as follows:
 - a. The total amount of this Contract shall not exceed \$43,350,436.00, as provided for in Attachment B – Categorical Budget revised August 2020.
 - b. Texas Targeted Opioid Response (TTOR) funding is to be expended as follows:
 - i. Fiscal Year 2018-2019, February 1, 2018 through April 30, 2019 \$ 7,375,000.00
 - ii. Fiscal Year 2019-2020, May 1, 2019 through September 29, 2020 \$13,042,410.00.
 - iii. Fiscal Year 2021, September 30, 2020 through August 31, 2021 \$11,466,513.00.
 - iv. Fiscal Year 2022, September 1, 2021 through August 31, 2022 \$11,466,513.00.
4. This Amendment adds additional one-time funding for fiscal year (FY) 2020 in the amount of **\$1,042,410.00**, for the term of September 1, 2019 through August 31, 2020.
5. This Amendment adds additional one-time funding for fiscal year 2021 and fiscal year 2022 in the amount of **\$22,933,026.00**, allocated as follows:
 - a. The total fiscal year 2021 funding is **\$11,466,513.00** for the term of September 1, 2020 through August 31, 2021.

- b. The total fiscal year 2022 funding is **\$11,466,513.00** for the term of September 1, 2021 through August 31, 2022.
6. Article VI, Contract Representatives, of the Contract Signature Document, is hereby deleted in its entirety and replaced with the following:




