## HHSC Contract No. HHS000270200015 Amendment No. 1

The Health and Human Services Commission ("HHSC") and South Texas Development Council ("Contractor") Parties to that certain aging and disability resource center contract effective September 1, 2019, and denominated HHSC Contract No. HHS000270200015 ("Contract"), as amended, now desire to further amend the Contract.

Whereas, the Parties desire to add \$249.00 to the Contract for Medicare Improvements for Patients and Providers Act ("MIPPA") services provided in state fiscal year ("FY") 2020;

Whereas, the Parties desire to add \$1,211.71 to the Contract for Money Follows the Person (MFP) services provided in FY 2020. The funds are allocated as follows:

- Local Contract Agency (LCA): \$29.00
- Housing Navigator (HN): \$1,182.71, Contractor will set aside \$910.71 to use for travel to attend the HN Conference in state fiscal year ("FY") 2020.

Whereas, the Parties desire to modify the requirements regarding the use of the SAR/VAR process and update the contact email addresses;

Whereas, the Parties desire to remove the requirements for use of the LTSS Portal, and

Whereas, the Parties desire to incorporate the completed Attachment O – Indirect Cost Rate Letter.

Now, Therefore, The Parties therefore agree as follows;

- 1. The contract budget for FY 2020 services is hereby increased from \$149,159.00 to \$150,619.71. The total amount of the Contract is therefore increased from \$648,015.00 to \$749,455.71. Contract Funds are hereby allocated in accordance with Exhibit C-2, Revised Funding Summary for State Fiscal Year 2020.
- 2. Attachment B, Budget is replaced in its entirety with the attached Attachment B-1, Revised Contract Budget.
- 3. Attachment A, Statement of Work is amended to remove Section 6.1 Administration of the LTSS Screen.
- 4. Article VIII(B) of the Signature Document is replaced in its entirety with the following:

- 7. This Amendment shall be effective on February 1, 2020 or the date last signed below, whichever occurs later.
- 8. Except as amended and modified by this Amendment, all terms and conditions of the Contract, as amended, shall remain in full force and effect.
- 9. Any further revisions to the Contract shall be by written agreement of the parties.
