

**HEALTH AND HUMAN SERVICES COMMISSION

AMENDMENT NO. 1**

The HEALTH AND HUMAN SERVICES COMMISSION ("System Agency") and YSLETA DEL SUR PUEBLO ("Grantee"), who are collectively referred to as the "Parties," to that certain Youth Prevention- Selective Program (YPS) Contract effective September 1, 2019 and denominated HHSC Contract No. HHS000539700123 ("Contract"), now desire to amend the Contract.

WHEREAS, the Parties desire to revise Section IV. Budget of the Signature Document to allow for successful completion of the Project.

NOW, THEREFORE, the Parties hereby amend and modify the Contract as follows:

1. **SECTION IV, BUDGET**, of the Contract is amended to reflect the below revised funding allocation breakdown:

The total amount of the Contract will not exceed \$1,075,835.00.

The funding allocated by System Agency, per fiscal year, is as follows:

1. Fiscal Year 2020, September 1, 2019 through August 31, 2020: \$204,921.00
2. Fiscal Year 2021, September 1, 2020 through August 31, 2021: \$204,921.00
3. Fiscal Year 2022, September 1, 2021 through August 31, 2022: \$204,921.00
4. Fiscal Year 2023, September 1, 2022 through August 31, 2023: \$204,921.00
5. Fiscal Year 2024, September 1, 2023 through August 31, 2024: \$204,921.00

The required Grantee match per State Fiscal Year is \$10,246.00.

Total Contract Value, per fiscal year, is as follows:

1. Fiscal Year 2020, September 1, 2019 through August 31, 2020: \$215,167.00
 2. Fiscal Year 2021, September 1, 2020 through August 31, 2021: \$215,167.00
 3. Fiscal Year 2022, September 1, 2021 through August 31, 2022: \$215,167.00
 4. Fiscal Year 2023, September 1, 2022 through August 31, 2023: \$215,167.00
 5. Fiscal Year 2024, September 1, 2023 through August 31, 2024: \$215,167.00
2. This Amendment No. 1 shall be effective as of the date last signed below. Any authorized expenditures by Grantee in conformity with the Contract between September 1, 2020, and the amendment effective date are hereby ratified.
 3. Except as amended and modified by this Amendment No. 1, all terms and conditions of the Contract, as amended, shall remain in full force and effect.
 4. Any further revisions to the Contract shall be by written agreement of the Parties.
