- c) The Contractor shall trim all edges including around the building(s) and concrete areas with commercial grade weed trimmer(s).
- d) The Contractor shall remove all loose and falling tree and hedge limbs, organic and nonorganic debris.
- e) The Contractor shall trim all hedges with commercial grade equipment intended for such purpose.
- f) Clean and blow parking lot of all organic and nonorganic waste.
