RELEVANT LEGAL AUTHORITY:

- Section 453(j)(10) of the Social Security Act provides the legal authority for the disclosure of National Directory of New Hires information for the purposes of the data match. 42 U.S.C. §653(j)(10).
- Section 11(e) of the Food and Nutrition Act of 2008, as amended by the Agriculture Act of 2014, Pub. L. 113-079, requires state agencies to request wage data directly from the National Directory New Hires to determine eligibility for and the correct amount of SNAP benefits. 7 U.S.C. §2020(e)(24).
- Section 453(k)(3) of the Social Security Act provides that a State or Federal agency that receives information from OCSE pursuant to section 453 of the Social Security Act shall reimburse OCSE for the costs incurred in furnishing the information, at rates which OCSE determines to be reasonable. 42 U.S.C. §653(k)(3).

Reimbursement Schedule: Upon execution of the agreement, OCSE will invoice the Texas SNAP agency \$33,879 for the costs of data comparisons selected for FY 23. The Texas SNAP agency must remit payment no later than 30 days following receipt of the invoice.

PERFORMANCE MEASUREMENT:

In accordance with section XIV of the Computer Matching Agreement (CMA) signed by both OCSE and the Texas SNAP agency and renewed by the execution of the Amendment and Renewal of the CMA, or a superseding CMA, on an annual basis, OCSE must receive a written summary of the performance outputs and outcomes attributable to the state agency’s use of National Directory of New Hires match results for the purposes set forth in the CMA.
